iPad Policy Acceptance and Insurance Plan

ISD 318 families have the option to purchase insurance through the school district as part of the ISD 318 1-1 Digital Student Learning Initiative (DSL_i). All families are encouraged to participate in the insurance option, but are not required to do so. Families who do not choose to purchase insurance are responsible for the full cost of repair and/or replacement of a damaged or stolen iPad. Insurance is available for 6th-12th grade students.

Claims

- To file a claim, both the parent and student must be present. The damaged iPad must be presented (or police report if theft occurred) to the school office.
- The parent and student will be required to complete a claim form and pay the deductible. Every effort will be made to immediately replace the iPad with the same model of the damaged or stolen one. If the same model is not available, the student may receive an older model iPad.

In order for iPads to remain covered by the insurance program, iPads must be charged with the Apple certified charging cable and power adaptor that is issued to each student.

Replacement chargers and iPad cases must be purchased in the office to ensure compatibility

- Charging Cables = \$10
 - One replacement cable issued at no cost through the insurance program with the exchange of the faulty or damaged cable
- Wall Charging Power Adaptor = \$10
- iPad Cases = \$26
 - School issued cases must remain on the iPad at all times, name tags must be visible in the card slot on case, do not decorate the case.
