- 2. The 12/10/19 minutes were agreed upon by consensus of the members present.
- 3. Superintendent's Report Sean Martinson: ISD 318's response to Governor's school closure announcement

Governor Walz directed all K-12 public and charter schools to close by Wednesday, March 18th for a two week period. All ISD 318 schools will close at the end of the school day on Tuesday, March 17 and reopen on Monday, March 30. This closure includes all after-school and extracurricular activities. We have been working on a continuous learning plan with administrators. The Minnesota Department of Education is defining distance learning to mean that a student receives daily interaction with their licensed teacher(s) and appropriate educational materials. We will share information with staff as soon as possible. Schools are required to provide child care, breakfast, and lunch to employee's school-aged children 12 years and under enrolled in the school district and emergency workers (including providers of healthcare, emergency medical services, long-term and post-acute care; law enforcement personnel; personnel providing correctional services; public health employees; firefighters and other first responders; and court personnel). At this point, the governor has stated that schooling will resume on March 30th, perhaps in the form of distance learning. It would be wise for parents and guardians to begin thinking about what would happen if our closure were to be extended longer and learning continues through a distance option. Schools will continue to pay hourly workers and they will be incorporated into our continuous learning plans moving forward. A website exclusively with COVID -19 information is being developed for ISD 318. Updates will be sent to staff via email.
